Ministry of Physical Infrastructure Development and Transport management, Road, Bridge and Provincial Building Office, Kaski has allocated funds from form **Gandaki Province Government** towards the cost of **Construction of Gandaki Ayurveda Hospital Building, Kaski** and intends to apply part of the funds to cover eligible payments under the Contract for **Construction of Gandaki Ayurveda Hospital Building, Kaski, Contract Identification No: RBPBO/W/B/NCB/22/082/83**. Bidding is open to all eligible as per Section V of bidding document.

2. **Road, Bridge and Provincial Building Office, Kaski** invites electronic bids from eligible bidders for the construction of **Construction of Gandaki Ayurveda Hospital Building, Kaski** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs. 3,75,00,000.00**
 - Minimum Work experience of similar size and nature: **Participation as Prime contractor, management contractor, or subcontractor, within the last ten (10) years, that have been successfully or are substantially completed One (1) Building Construction Contract with a value of at least NRs: 2,00,00,000.00**
3. Bidder who chooses to submit their bid electronically, Bidders are required to submit two separate bid response documents, one containing (i) the Technical Bid and the other (ii) the Price Bid, as per the provision of ITB 21 of the Bidding Document.
 4. Eligible Bidders may obtain further information and inspect the Bidding Documents at PPMO e-GP system www.bolpatra.gov.np/egp.
 5. A complete set of bidding document may be downloaded from PPMO's Web Site www.bolpatra.gov.np. Bidders, submitting their bid electronically, should deposit the cost (as specified above) of bidding document of **NRs. 5000** in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 6. Pre-bid meeting shall be held at **Road, Bridge and Provincial Building Office, Kaski** at **2083/04/05 i.e 21st July, 2026 at 13:00 Hrs.**
7. Electronic bids must be submitted to the office **Road, Bridge and Provincial Building Office, Kaski** through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 Noon on 2083/04/15 i.e 31st July, 2026.** Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 on 2083/04/15 i.e 31st July, 2026** at the office of **Road, Bridge and Provincial Building Office, Kaski**. Bids must be valid for a period of **90 Days** from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 15,00,000.00 (Fifteen Lakhs Only)** which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
